ACTION: The Owensboro-Daviess County Metropolitan Planning Organization hereby modifies the FY 2019-2024 Transportation Improvement Program (TIP). This modification reflects the addition of capital and operational transit items.

DESCRIPTION: Purchase of capital items for Owensboro Transit System and Operational Costs

SCOPE OF WORK: Grouped Projects (Purchase of New Buses, Rehabilitation of Transit Vehicles, Transit Operating Assistance, Transit Operating Equipment, Renovation or Reconstruction of Transit Facilities)

TYPE OF FUND: CARES Act – Section 5307

FY: 2021

AMOUNT: \$4,837,604

OTHER INFORMATION: This Modification adds new projects to Table 6 of the Owensboro-Daviess County 2014-2019 Transportation Improvement Program to reflect capital purchases and operational costs for the Owensboro Transit System. These projects are of a project type identified in the Grouped Projects Table of the TIP; therefore, a formal TIP Amendment is not necessary. A listing of Grouped Projects has been included in the TIP allowing planning process stakeholders and the general public to be informed of the types of potential projects that may be added to the TIP and MTP by Administrative Modification. TIP actions for these projects will not require additional public review. The identification of specific projects from the Grouped Projects Table involves a commitment of additional funding for the project by the project sponsor (FTA/OTS). This additional funding maintains financial constraint of the TIP and MTP documents, and no additional financial constraint analysis by the MPO is needed.
