

I. CALL TO ORDER

Chairman Steve Henry called the meeting to order at 11:45 a.m. and led with the Pledge of Allegiance. Mickey Dunbar opened the meeting with prayer.

II. OLD BUSINESS

A. <u>Secretary's Report</u>

Secretary Johnny Roberts presented the minutes of the August 9, 2023, GRADD Board of Directors meeting for approval.

A motion was made by Johnny Roberts and seconded by Randy Greenwell to approve the minutes of the August 9, 2023, GRADD Board of Directors meeting. A vote was taken and the motion carried.

B. Treasurer's Report

Treasurer Curtis Dame presented the Treasurer's Report for the period of July 1, 2022 – July 31, 2023.

A motion was made by Curtis Dame and seconded by Brad Schneider to approve the Treasurer's Report for the period July 1, 2022 – July 31, 2023, which is subject to audit. A vote was taken and the motion carried.

III. NEW BUSINESS

A. <u>1st Quarter Revised Budget</u>

Treasurer Curtis Dame presented the 1st Quarter Revised Budget for review and approval. The revision includes roughly \$3 million in additional adjustments through the H2O Program, traditional Aging program and the Waiver program. Expenses have been updated to reflect additions to contractual services and direct program expenditures. This increase is due to the additional funding in the Waiver Department and the H2O program.

Chairman Steve Henry also thanked GRADD board member Lauren Osowicz for assisting the committee with the flower arrangements.

Chairman Steve Henry announced GRADD and Webster County were the recipients of the 2023 Peggy Satterly Spirit of Kentucky Award at the Governor's Local Issues Conference. The award acknowledged the Lisman Workforce Complex project. The project offers technical education and certification for trades in the GRADD region. This project has allowed Madisonville Community College the opportunity to expand its class sizes for the CDL, utility lineman and newly created diesel mechanic programs.

Joanna Shake explained the award's namesake, Peggy Satterly, served the Commonwealth of Kentucky for 48 years and worked with 11 gubernatorial administrations. She added that Peggy Satterly was regarded as an outstanding public servant.

Joanna Shake provided an overview of the 2024 Impact Reports summarizing the district's projects and programs and showcasing GRADD's commitment to sustainability and advancement of the region.
