## II. OLD BUSINESS

## A. Approval of Minutes

The minutes of the July 10, 2019, meeting of the GRADD Hazard Mitigation Council were presented for approval.

A motion was made by Pat Hardesty and seconded by Betty Howard to approve the minutes of the July 10, 2019, meeting of the GRADD Hazard Mitigation Council. A vote was taken and the motion carried.

#### III. NEW BUSINESS

## A. <u>Nominating Committee</u>

The nominating committee recommended Jeremy Moore and Buzzy Newman serve as chairman and vice-chairman, respectively for another term.

A motion was made by Trey Pedley and seconded by Kenny Garrett to approve the nominating committee's recommendation of chairman and vice-chairman. A vote was taken and the motion carried.

## B. 2021 Hazard Mitigation Plan Update

Blake Edge gave an update on the plan process to-date. He discussed the value of the plan for each jurisdiction in the GRADD region and the planning strategy for the update process. Mr. Edge presented the timeline of the process, which began in the fall of 2019 with the risk assessment, and is currently in the mitigation strategy phase of the community meetings. The plan will be completed for review in the summer of 2020 and will be ready for adoption by each community in the fourth quarter of 2020.

#### C. Seismic Study

Drew Andrews presented an update of the seismic study currently being performed for the GRADD region. He discussed project goals and deliverables for participants in the study and mentioned the timeline of the project. Mr. Andrews will have some final mapping complete to present at the July Hazard Mitigation Council meeting.

#### D. Pilot Project Update

Dr. Sandra Pinel and Chandra Woolums gave an update on the Pilot Project with the Department of Homeland Security, FEMA, KY Emergency Management, University of Kentucky, and GRADD. This project is studying the dependencies and resiliency of the area infrastructure. of work. The first community meeting to discuss the project and do a trial run with data will take place this week in Whitesville. The goal of the project is a repeatable process that can be used by other units of government around the United State.
