I. <u>CALL TO ORDER</u>

Chairman Steve Henry called the meeting to order at 9:06 a.m. He welcomed everyone to the meeting.

II. CONSIDERATION OF MINUTES

Chairman Henry offered the minutes of the May 29, 2019, meeting of the GRADD Regional Transportation Committee for approval.

A motion was made by Brian Howard and seconded by Donnie Mayton to approve the minutes of the May 29, 2019, GRADD Regional Transportation Committee meeting. A vote was taken and the motion carried.

III. OLD BUSINESS

A. None.

IV. NEW BUSINESS

A. Owensboro-Daviess County Regional Airport Update

Rob Barnett, Airport Director, updated the committee that Allegiant Airlines had recently been approved for two more years as Essential Air Service. He stated that Owensboro is ranked third out of 100 markets for passenger boardings. Beginning in January, Cape Air will add flights to Nashville providing travelers with the option of flying to St. Louis and/or Nashville for connecting flights. He also spoke about the Pilot Program with Cape Air that provides training in Owensboro. The program currently has three students and is interested in expanding its class size. He also invited local fire departments to visit the new state-of-art fire station located at the airport.

B. GRADD Priority Point Allocation (Boost)

Gina Boaz presented the GRADD sponsored projects for the Priority Point Allocation (Boost). KYTC allocated a total of eleven (11) projects for GRADD to add to the fifteen (15) point boost. Discussion was held as to which projects best address the criteria outlined in the GRADD Prioritization Plan and potential highway district boosts. After

considerable discussion, the eleven (11) projects were determined with at least two (2) from every county. The approved list is attached.

A motion was made by Adam O'Nan and seconded by Charlotte Whittaker to approve the eleven (11) projects to provide the priority point (boost). A vote was taken and the motion carried.

C. GRADD RTC Committee Activities

Gina Boaz provided a list of meeting activities for FY2020. The list is attached.

A motion was made by Donnie Mayton and seconded by Joanne Kendall to approve the Committee Activities for FY2020. A vote was taken and the motion carried.

V. UPDATES

A. <u>Highway District Office Update</u>

Deneatra Henderson reported on the following projects:

Daviess – I-165 upgrade will be complete by August 30.

- US 60 near Oakford Rd., flooding relief project is under construction.

Ohio – US 231 safety project will be completed this summer.

A scoping study on the feasibility of the West KY Parkway upgrade to interstate standards has begun. The initial meeting is scheduled for August 19 in Muhlenberg County with another one planned for Ohio County in the near future.

McLean – US 431 and Muhlenberg County Line overflow structure removal will be completed this summer.

Union – US 60 at Henderson County line flooding relief project has begun with continued finishing work over the next month.

Webster - KY 835 bridge project will be completed this week.

B. Other Updates

Donnie Mayton advised the committee that over 500 bicyclists will be in Daviess and Henderson Counties this weekend for the 100-mile Bourbon and Bluegrass Century Ride.

It was created to provide assistance to the Board in the formulation of regional transportation policy, provide a forum for elected officials to work together in solving regional transportation problems, act as an advocacy body on transportation related matters as needed, act as a data and information base for the public-at-large and to provide legislators with the information necessary to make equitable legislative decisions, provide a forum for local public involvement into the regional planning process, provide local transportation officials the opportunity to prioritize transportation projects, and to provide input for the Kentucky Transportation Plan. The committee includes a broad-based representation of various stakeholders and interested parties.

The GRADD Regional Transportation Committee has established the last Wednesday of every third month at 9:00 a.m. CST as the regular meeting time. The meetings are generally held at the GRADD office at 300 GRADD Way in Owensboro, Kentucky. Occasional meetings are held in one of the seven counties represented within the GRADD. In the event that a special meeting is required, it will be on an alternate month.
