I. CALL TO ORDER

IV. NEW BUSINESS

A. GRADD Regional Transportation Committee Guide

Gina Boaz presented the 2019 GRADD Regional Transportation Committee Guide. She stated the guide is a resource that lists the role of the committee, information about developing Kentucky's Highway Plan, who to call, and transportation terms. The guide will also be available on the GRADD website. A list of committee members for 2019 was also provided.

B. KY SHIFT Process and GRADD Sponsored Projects

Gina Boaz informed the committee that she, KYTC District Office Chief District Engineer Deneatra Henderson, Nick Hall, and other KYTC staff met with each county judge to determine project priorities and which projects they would recommend to GRADD to sponsor. She reviewed each of those projects. She stated that KYTC District Office Two will be sponsoring 17 of the projects leaving 26 projects identified for sponsorships. GRADD has 23 sponsorships available; therefore, discussion was held regarding which projects to sponsor. It was determined that all projects identified but two from Ohio County and one from Webster County could be sponsored by GRADD. Judge David Johnston and Judge Steve Henry agreed to not sponsoring project number eight and nine in Ohio County and project number eight in Webster County. The sponsored project list is attached.

A motion was made by Adam O’Nan and seconded by Mike Burden for GRADD to sponsor all but the three projects. A vote was taken and the motion carried.

C. Draft SHIFT Prioritization Plan

Gina Boaz presented the Draft Strategic Highway Investment Formula for Tomorrow (SHIFT) Prioritization Plan. She noted that the committee is currently in phase one of the plan. A copy of the plan is attached.

A motion was made by Charlotte Whittaker and seconded by Candance Brake to approve the Draft SHIFT Prioritization Plan. A vote was taken and the motion carried

DRAFT 2019 Prioritization Plan Green River Area Development District (GRADD)

INTRODUCTION

The purpose of this document is to provide a plan and methodology to the Kentucky Transportation Cabinet (KYTC) for the GRADD 2019 Prioritization Plan. The prioritization process will be used as input for the Recommended Kentucky Highway Plan, to be submitted to the next session of the Kentucky General Assembly in 2020.

Kentucky's current highway plan promises more than \$6 billion in unfunded transportation projects. The cost is ten times greater than the state funds available. As a result, citizens cannot depend on the plan as a reliable guide for improvements.

In 2017, KYTC developed a more data-driven, objective and collaborative approach to determine the state's transportation funding priorities. The Strategic Highway Investment Formula for Tomorrow (SHIFT) is a prioritization model that will bring balance and dependability to Kentucky's over-programmed highway plan.

SHIFT uses quantitative data such as crashes, fatalities, traffic volumes, delays, employment to assess the benefits of planned projects and compare them to each other. Transportation project types to be prioritized using SHIFT include:

- Safety Improvements
- Road Widening
- Reconstruction
- New Routes and Interchanges

The program also includes collaboration with local leaders throughout the process to help shape regional funding priorities. Through this collaboration, projects will be selected for prioritization, or "sponsored", at one of the following levels:

- District Level - selected by the KYTC Highway District 2 Office (District 2)
- Regional Level - selected by the GRADD Regional Transportation Committee (GRADD RTC). This includes projects for the counties of Hancock, McLean, Ohio, Union and Webster.

SHIFT PRIORITIZATION PROCESS

KYTC will use SHIFT to prioritize and fund about \$50 million in transportation projects in the current biennium. The process will be divided into two phases.

Phase One

Using the statewide formula, KYTC will determine the number of projects each ADD, HDO, and MPO may sponsor. For 2019, KYTC has allotted the following number of projects:

- District 2: 55 sponsorships
- GRADD: 23 sponsorships (excludes Daviess and Henderson counties)

Timeline:

- February – GRADD and HDO staff will meet with local officials to select 4-5 projects per county to be considered for sponsorship by the GRADD RTC
- February 27 – GRADD RTC approves sponsored projects and DRAFT Prioritization Plan. Sponsored projects are then submitted to KYTC.
- May – GRADD RTC Draft Prioritization Plan submitted to KYTC

Phase Two

KYTC scores projects based on safety, asset management, congestion, economic growth and benefit/cost, with a focus on statewide importance. These scores are returned to the district and regional levels for use in further scoring.

Timeline:

- July – GRADD RTC meeting notices and DRAFT 2019 Prioritization Plan will be made available on the GRADD website
- July 31 – GRADD RTC meets to assign points to projects to adjust priorities
- August – All scores will be submitted to KYTC
- October/November – KYTC Central Office Develops Draft Highway Plan
- November/December – KYTC delivers Draft Highway Plan to the Governor

REGIONAL CRITERIA FOR POINT ALLOCATION

GRADD RTC members in attendance will add points based on the criteria below until all the points are depleted:

- 1) Currently funded in the 2018 Kentucky Highway Plan
- 2) Regional significance
- 3) Safety
- 4) Economic development
