

I. <u>CALL TO ORDER</u>

Chair Adam O'Nan called the meeting to order at 1:00 p.m.

II. CONSIDERATION OF MINUTES

Chair Adam O'Nan presented the minutes of the November 25, 2024, meeting of the GRADD RTC for approval.

A motion was made by Brian Howard and seconded by Larry Tellman to approve the minutes of the November 25, 2024, GRADD RTC meeting. A vote was taken and the motion carried.

III. OLD BUSINESS

A. <u>Strategic Highway Investment Formula for Tomorrow (SHIFT) Process</u>

Chair Adam O'Nan called on Jennifer Alvey, GRADD's GIS Analyst, to share projects for consideration for sponsorship for SHIFT. Ms. Alvey explained that out of 125 projects in its list of eligible projects, the RTC was allotted 21 projects to sponsor in the 2026 SHIFT process. Ms. Alvey had already met with each judge/executive individually to determine the top five or six priority projects for each county, and noted with five counties represented in the RTC, it made sense for each county to get four sponsorships, and then for the committee as a whole to determine the 21st project.

Ms. Alvey presented each county's priority projects to the committee. Chair O'Nan asked for questions or comments. The committee agreed to sponsor the following projects:

Hancock County

- Address safety concerns at the intersection of KY 2181 and Ed Brown Road
- Address safety concerns on KY 271 from KY 1847 to US 60
- Address safety concerns on KY 69 near Tick Ridge Road
- Reconstruct US 60 from MP 2.2 in Lewisport to KY 1957

McLean County

- Address issues with bridges on KY 136
- Address safety concerns at the intersection of KY 81 and KY 138
- Address safety concerns at the intersection of KY 140 and KY 815
- Improve the intersection of KY 56 and KY 1233
- Improve the intersection of US 431 and KY 250

Ohio County

- Improve the turning radius of the intersection of KY 54 and KY 69
- Reconstruct KY 69 from KY 85 to Goshen Road (KY 276)
- Address left tun issues on US 231 at Cromwell Road
- Address left turn issues at both Perdue entrances on US 231

Union County

- Improve KY 56 from Morganfield to KY 141
- Reconstruct US 60 from Waverly to Corydon
- Reconstruct US 60 from the Morganfield bypass to Waverly
- Improve US 60 from KY 950 to KY 492

Webster County

- Add a right turn lane to KY 132 at Canaan Ridge Park
- Address flooding and safety concerns on KY 138 from KY 120 to the railroad bridge in Slaughters
- Improve KY 56 from US 41 in Sebree to the McLean County line
- Improve US 41A from KY 2836 to Vanderburg-Lisman Road

A motion was made by Johnny "Chic" Roberts and seconded by Donnie Mayton to approve the list of 21 projects as selected. A vote was taken and the motion carried. GRADD Regional Transportation Committee Meeting Minutes March 24, 2025 – Page 4
