# I. <u>CALL TO ORDER</u>

Chairman Pete Conrad called the meeting to order at 1:30 p.m. and noted there was a quorum.

#### II. <u>OLD BUSINESS</u>

A. <u>Secretary's Report</u>

Chairman Pete Conrad presented the minutes of the June 17, 2021, meeting of the GRADD Water Management Council for approval.

A motion was made by Pete Conrad and seconded by Randy Sallee to approve the minutes of the June 17, 2021, meeting of the GRADD Water Management Council as presented. A vote was taken and the motion carried.

## III. <u>NEW BUSINESS</u>

# A. <u>GRADD Personnel Update</u>

Chairman Conrad turned the meeting over to Cheyton Pendley, the new Infrastructure Planner at GRADD. Mr. Pendley introduced himself to the Council, stating he is a native of Ohio County and a graduate of Lindsey Wilson College. He welcomed members of the Council to contact him should they have any questions or concerns about projects to bring before the Council.

# B. <u>Guest Speaker</u>

Chairman Conrad called on Mr. Pendley to turn the meeting over to Paula Payne, Workforce Development Program Assistant, to share information about the H2O Apprentice Program. Ms. Payne explained Workforce Director Jodi Rafferty secured a DRA grant last year for \$150,000 for Kentucky Rural Water to hire apprentices for water utilities. The goal of the program is to have ten apprentices placed in the DRA counties of Henderson, McLean, Union and Webster Counties. Eight apprentices have already been placed. The grant pays \$12,000 of the salary of the apprentice, as well as the cost of classes for apprentices to become certified operators. Ms. Payne encouraged the Council to reach out to her if they wanted more information about the program.

# C. <u>Updates</u>

Chairman Conrad asked Mr. Pendley if he had any updated regarding ARPA funds. Mr. Pendley did not but asked if anyone for Kentucky Infrastructure Authority (KIA) wanted to share any updates. Sandy Williams shared Senate Bill 36 Updates. Ms. Williams shared 479 applications for \$705 million in requests had been received, yet only \$250 million has been appropriated. Of the applications received, 111 project were for unserved drinking water totaling \$163 million; 17 were consent decree project for \$127 million. Forty projects are currently under consideration. Applications are due November 19<sup>th</sup>. KIA is looking for local consensus. Ms. Williams encouraged the Council to consider having a backup project.

#### D. <u>Consideration of Projects</u>

Two water projects were presented for approval.

- 1. WX211830052 Ohio County Water District Meter Replacement
- 2. WX21183054 Chiggerville Lane Waterline Extension

A motion was made by Curtis Dame and seconded by Vicki Hughes the above-mentioned water GRADD Water Management Council Meeting Minutes September 16, 2021 – Page 4

projects be approved. A vote was taken and the motion carried.

## D. <u>Planning with Pete</u>

Chairman Conrad thanked everyone for attending. He reminded the Council to contact him or Cheyton Pendley should they have any questions about ARPA fund projects. He asked Mr. Pendley if fall system visits were planned, and Mr. Pendley replied there would be spring system visits instead. Ranking meetings will be taking place in the next few weeks.
