### I. CALL TO ORDER

#### II. OLD BUSINESS

## A. Secretary's Report – September 5, 2019

## III. <u>NEW BUSINESS</u>

## A. Guest Speaker

Chairman Conrad introduced guest speaker Rusty Anderson from Terra Graphics, LLC. Mr. Anderson demonstrated several mapping services and graphics that could be useful to utilities who have a serviceable population of less than 10,000 connections. Mr. Anderson also noted there are asset management tools that can be utilized by the utilities which could make the jobs of operator's easier when determining age of lines and other equipment, and where replacements need to be made.

#### B. ADD Infrastructure Commitment Update

Jiten Shah introduced Mike Burress, Executive Director of the Lincoln Trail Area Development District and member of the ADD Infrastructure Work Committee, for a legislative update. Mr. Burress explained that the Legislative Research Commission (LRC) has put together a task force on infrastructure and he is the Area Development District (ADD) representative on this committee. Mr. Burress presented the council with the recommendations made by the LRC for infrastructure and how the committee responded to them.

## C. Regional Rankings

Skyler Stewart announced that regional rankings are due to KIA on December 13, 2019, and they have been handed out to the council for discussion.

A motion was made by Betty Howard and seconded by Tom Williams to submit the GRADD regional water and sewer project rankings, as presented. A vote was taken and the motion carried.
