I. CALL TO ORDER

Chairman Pete Conrad called the meeting to order at 10:30 a.m., and noted there was a quorum. He called roll to denote a quorum, requested that everyone mute their microphones unless speaking and thanked everyone for attending the Zoom meeting.

II. OLD BUSINESS

A. Secretary's Report – April 23, 2020

Secretary Durhan-Hayes presented the minutes of the April 23, 2020, meeting of the GRADD Water Management Council for approval.

A motion was made by Gary Scheffer and seconded by Walt Beasley to approve the minutes of the April 23, 2020, meeting of the GRADD Water Management Council. A vote was taken and the motion carried.

### III. NEW BUSINESS

#### A. Guest Speaker

Chairman Conrad introduced guest speaker Heather Stevenson of Kentucky Rural Water. Ms. Stevenson noted she is the Workforce Development Coordination for KRWA and discussed the apprenticeship program that KRWA has to offer. Ms. Stevenson also noted that KRWA had two training upcoming, one on June 23, 2020 at 9am and another on June 24, 2020 at 9am to discuss rate adjustment training.

#### B. KIA Draft 2020 Clean Water State Revolving Fund Intended Use Plan

Chairman Conrad then called upon Edith Hablieb, Executive Director of Kentucky Infrastructure Authority. Ms. Hablieb noted that the Intended Use Plan was similar to last years plan and the public meeting will be held at 2:30 ET. Ms. Hablieb also mentioned that invitations for the SRF program had already been sent out and there were just minor changes to be made to the plan. She noted there would be up to \$1,000,000 offered for forgivable loans in the current IUP and the disadvantaged rate would be .25% interest.

#### C. Consideration of Projects

Skyler Stewart presented three (3) new water projects for approval.

A motion was made by Emery Thomas and seconded by Tom Williams to approve the above-mentioned wastewater projects. A vote was taken and the motion carried.

Chairman Conrad expressed his gratitude to the Green River District Health Department with their recent help with a COVID-19 spread scare. Chairman Conrad also wanted to let everyone know that if they had any issues pop up they could call him any time.

Vice Chair Higdon asked the group if anyone had assistance completing their AWIA that was due in June of 2021.
