U.S. Department of Justice Now Accepting Applications for 2025 COPS Hiring Program

Owensboro, KY — The U.S. Department of Justice has officially opened the application period for the FY25 Community Oriented Policing Services (COPS) Hiring Program (CHP)—a competitive grant designed to support the hiring or rehiring of law enforcement officers, with the goal of strengthening community policing and enhancing public safety across the nation.

This opportunity is open to **local**, **state**, **tribal**, **and territorial law enforcement agencies**, regardless of size. Through this funding, departments can expand patrol capacity, reinstate positions lost due to budget cuts, or support specialized roles such as school resource officers.

Key Funding Highlights:

- Up to \$125,000 per officer over a three-year period
 - Requires a 25% local cash match, though waivers may be available for fiscally challenged agencies
- A maximum of one position may be requested by agencies with fewer than 10 officers
- Agencies may request up to 20% of their sworn force, capped at 50 officers
- Funding period includes a required 12-month retention period after funding ends

Additional consideration will be given to applications from:

- Rural or underserved communities
- Departments with a focus on crime reduction strategies
- Agencies not funded under the FY24 cycle

- JustGrants Submission: July 1, 2025 at 4:59 PM ET

"The COPS Hiring Program offers a meaningful opportunity for departments to strengthen their workforce and invest in community policing," says GRADD Community Development Planner Amy Matheny.
