ACTION: The Owensboro-Daviess County Metropolitan Planning Organization hereby modifies the FY 2023-2028 Transportation Improvement Program (TIP). This modification reflects the addition of transit funds for Owensboro Transit System.

DESCRIPTION: Operating Costs and Capital Purchase

SCOPE OF WORK: Grouped Projects (Transit Operating Assistance and Small Transit Passenger Shelters and Kiosks)

TYPE OF FUND: 5310

FY: 2027

AMOUNT: \$256,252

OTHER INFORMATION: This Modification adds a new project to Table 5 of the Owensboro-Daviess County MPO's 2023-2028 Transportation Improvement Program, to reflect Operating Assistance for the Owensboro Transit System (OTS). This project is of a type identified in the Grouped Projects table of the TIP, therefore a formal TIP Amendment is not necessary. A listing of Grouped Projects has been included in the TIP, allowing the planning process stakeholders and the general public to be informed of the types of potential projects that may be added to the TIP by Administrative Modification. TIP actions for these projects will not require additional public review. The identification of specific projects from the Grouped Projects table involves a commitment of additional funding for the project by the project sponsor (FTA/OTS). This additional funding maintains financial constraint of the TIP document, and no additional financial constraint analysis by the MPO is needed.
