**ACTION:** The Owensboro-Daviess County Metropolitan Planning Organization hereby modifies the FY 2019-2024 Transportation Improvement Program (TIP). This modification reflects the awarding of a grant to Owensboro Transit System (OTS) for Low- or No-Emission Vehicles

**DESCRIPTION:** Purchase of an electric bus and charging station as well as installation of a charging station

**SCOPE OF WORK:** Grouped Projects (Purchase of New Bus, Transit Operating Equipment, Reconstruction or Renovation of Transit Facilities)

**TYPE OF FUND:** Low- or No-Emission (Low/No) Grant Program

**FY:** 2021

**AMOUNT:** \$927,629

**OTHER INFORMATION:** This Modification adds a new project to Table 6 of the Owensboro-Daviess County 2014-2019 Transportation Improvement Program to reflect capital purchases and operational costs for the Owensboro Transit System. This project is of a project type identified in the Grouped Projects Table of the TIP; therefore, a formal TIP Amendment is not necessary. A listing of Grouped Projects has been included in the TIP allowing planning process stakeholders and the general public to be informed of the types of potential projects that may be added to the TIP and MTP by Administrative Modification. TIP actions for these projects will not require additional public review. The identification of specific projects from the Grouped Projects Table involves a commitment of additional funding for the project by the project sponsor (FTA/OTS). This additional funding maintains financial constraint of the TIP and MTP documents, and no additional financial constraint analysis by the MPO is needed.
